From HFP client to HFP CEO... Mark Hartman takes over!



Mark D. Hartman, of Middleville, Michigan, is the new Executive Director, President, and CEO of Humanity for Prisoners (HFP). The announcement was made by Board Chair Russ Bloem.

Mark has an impressive professional history, including 10 years of service in the commercial nuclear power industry and as a consultant to the U.S. Department of Energy. He then joined the Boeing Company and spent 12 years in the aerospace and defense industry, where he held the position of Global Data Privacy Program Manager. For the past two years he has served as an Enterprise Resource Planning system implementation Core team member and Production Supervisor for RoMan Manufacturing Inc. of Grand Rapids. He holds a Master of Business Administration degree from Seattle University, a Bachelor of Science in Construction Management from Syracuse University, and more recently a Bachelor of Arts in Faith and Community Leadership with a minor in Social Work from Calvin University.

Here's the part of Mark's history that caught the attention of the HR Committee: He was incarcerated in the Berrien County Jail and Michigan Department of Corrections (MDOC) at prisons in Jackson, Muskegon, and Ionia for 12 years between 2008 and 2020! Incarceration proved to have a transformative effect in his life and mission, all of which began with a 2009 letter leading to a chance meeting with HFP founder, Doug Tjapkes.

While in custody with MDOC, Mark led efforts within prison communities to work on behalf of disenfranchised groups as an inside HFP liaison. He helped facilitate communications between HFP staff and clients, constituents, community organizations, and elected officials to improve quality of life issues and respond to prisoner health emergencies throughout Michigan.

After getting a slow start due to some health issues, he's anxious to get up-to -speed. Welcome aboard, Mark!

Meet Liz!


HFP's new Intake Specialist settles in

It wasn't coincidence that the HR Committee recommended the appointment of Mark as our new CEO.

And, Praise God, it wasn't coincidence that the Board of Directors named Mark Hartman to that position! He's only the third person in the 22-year history of HUMANITY FOR PRISONERS to serve in that role of leadership.

The women that had one yesterday were so excited that they processed their visits timely and they were able to have complete visits with their families! Thank you so much for speaking for the women in here. We appreciate all of you at HFP.
