In 2019, three inmates of Michigan's only prison for women filed a class action lawsuit claiming that damp and humid conditions at WHV, along with poor ventilation, produced persistent mold that damaged their health. Krystal Clark and Hope Zentz, clients of HFP, are the named plaintiffs in litigation, along with their friend Paula Bailey, who has now been released.

Without question you will get a clearer picture as to how and why I was nudged into forming this amazing organization. SOLE DEO GLORIA!



After it was filed, the MDOC had argued that the suit should be thrown out because the women didn't properly exhaust the grievance process. Paul Egan, veteran reporter for the Detroit Free Press and a frequent writer on state prison issues, reports that, in her 38-page opinion, U.S. Magistrate Judge Elizabeth Stafford blasted the grievance process as one that obstructs, deflects and improperly rejects legitimate and timely complaints! She recommended to US District Judge Stephen Murray that the suit be allowed to proceed. Royal Oak attorney Cary McGehee, who represents our clients, told Egan that this ruling "will have far-ranging ramifications and affect the rights of all prisoners within the MDOC." HFP staffers have long complained about the troublesome grievance process.

Krystal is in bad health and her loved ones are clamoring for an immediate release. Best wishes to our clients and special thanks to Paul Egan for his fine reporting!
