## From the Desk of Doug Christmas

**Just Another Day for Some** 



Many agree that, on the day after Christmas, there's a letdown. Regardless of religious beliefs, Christmas is still a time of feast and family, gifts and gift-giving, for most of us.

That's not true in prison. Most occupants will tell you that it's just another day. Perhaps a slightly improved meal. Perhaps a slight consumption increase of spud juice (the term for home-made liquor) to celebrate. Perhaps a slight reduction in the fighting, yelling and rancor. Perhaps some kinder words from overworked officers. But mostly, same old, same old. As our team took the day off to celebrate, holiday requests continued. I'm reminded of this poem:

When the song of the angels is stilled, When the star in the sky is gone, When the kings and the princes are home, When the shepherds are back with their flocks,

The work of Christmas begins:
To find the lost,
To heal the broken,
To feed the hungry,
To release the prisoner,
To rebuild the nations,
To bring peace among people,
To make music in the heart.

has a forum consisting of staff members and elected inmates, who decide how money will be spent from what is called the Prisoner Benefit Fund. Dollars come into this fund from the prison store and the prison vending machines and are often used to purchase additional equipment for the benefit of the incarcerated. *But*, committee members may also donate to approved charitable organizations. In 2024, HFP received \$10,500, thanks to the efforts of our clients behind bars. The grants ranged from \$500 to \$2,500 and came from six different state correctional facilities!


That's only part of the story. In addition to those collective gifts, HFP received donations from more than 15 incarcerated clients (whose wages may be 70 cents an hour!) in 2024, totaling more than \$375.00!
