New Partnership with Dolly Parton Imagination Library!



We are excited to announce that HFP has officially partnered with United Way of the Lakeshore and Dolly Parton's **Imagination** Library (DPIL) to offer a fantastic new service for the children of incarcerated individuals. Effective

immediately, we can now enroll incarcerated parents' children, aged 0-5, in DPIL's book-gifting program. This initiative sends free, high-quality books directly to children from birth to age five, regardless of the family's income. Each month, the child will receive an age-appropriate book addressed specifically to them, all at no cost to the parent or family. The goal of this collaboration is to enhance literacy among the children of incarcerated parents and to strengthen the bonds between parents, children, and their caregivers. 
